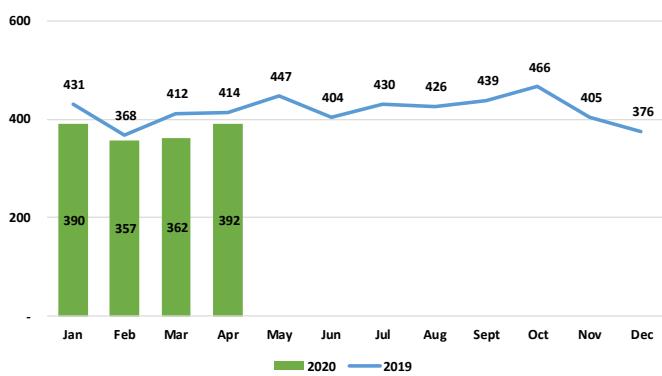

Tren Produksi TBS AALI* – 000 Ton



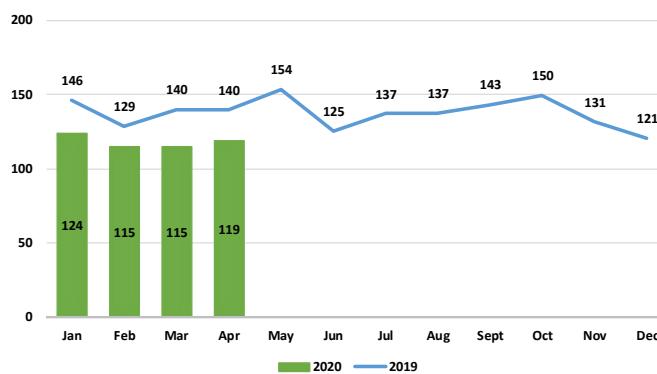

Produksi CPO AALI mencapai 473 ribu ton pada April 2020

Produksi CPO AALI mencapai 473 ribu ton pada April 2020 atau mengalami penurunan sebesar 14,7% dibandingkan dengan tahun lalu seiring dengan turunnya produksi TBS sebesar 7,7%. Penurunan ini diakibatkan oleh dampak kemarau panjang pada tahun 2019 yang masih dirasakan hingga saat ini.

Tahun 2020, perekonomian dunia menghadapi tantangan yang cukup berat terutama terkait dengan pandemi Covid-19. Hal tersebut mengakibatkan harga CPO pada industri kelapa sawit mengalami penurunan yang cukup signifikan seiring dengan penurunan harga *crude oil*. Namun, operasional perusahaan masih berjalan normal dengan memperhatikan prosedur kesehatan dan keselamatan. Ke depannya perusahaan akan terus memantau kondisi pandemi Covid-19 dan dampaknya terhadap perusahaan.

AALI mencatat Pendapatan Bersih sebesar Rp 4,8 triliun pada 31 Maret 2020

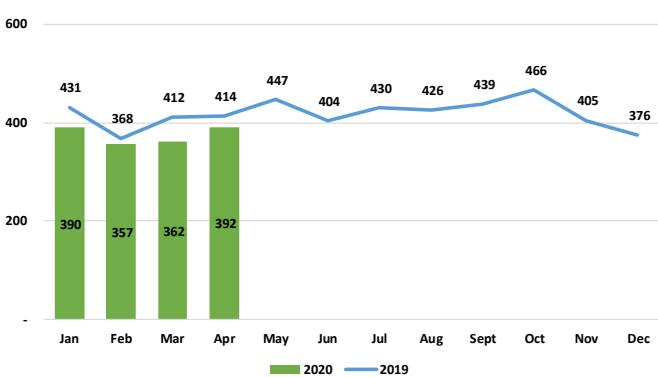
Hingga Maret 2020, AALI mencatat penurunan pada volume penjualan CPO & produk turunannya sebesar 18,6%. Namun, pendapatan bersih mengalami peningkatan 13,3% menjadi Rp 4,8 triliun yang disebabkan oleh meningkatnya harga jual sebesar 44,5%. Salah satu penyebab meningkatnya harga jual yaitu pelaksanaan mandatori B30 oleh Pemerintah Republik Indonesia yang dilaksanakan mulai 1 Januari 2020. Laba bersih yang diatribusikan kepada pemilik saham pada Maret 2020 sebesar Rp 371 miliar atau naik sebesar 891,8% dibandingkan periode yang sama pada tahun lalu

AALI's FFB Production Trend* – 000 Ton



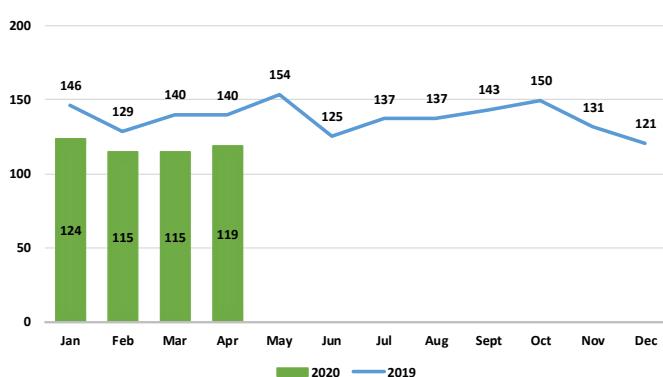

AALI's CPO Production has reached 473 thousand Tons at April 2020

AALI's CPO production has reached 473 thousand tons at April 2020 or 14.7% lower compare to last year, which were in line with FFB Production decrease of 7.7%. This decrease were mainly due to long term drought in 2019 that still give some impact until now.

In 2020, global economy facing quite a challenge especially related to Covid-19 pandemic. This condition make CPO price for Palm Oil Industry decrease significantly in line with the decrease of crude oil price. However, the Company still operating normally with strict health and safety procedures. Furthermore, the company will constantly monitoring the Covid-19 pandemic condition and its impact to the company.

AALI's recorded Rp 4.8 trillion Net Revenue at March 2020

As of March 2020, AALI recorded 18.6% decrease on sales volume of it's CPO & it's derivatives. However, the net revenue increased by 13.3% to Rp 4.8 trillion as the result of 44.5% increase in average CPO selling price, which were impacted from B30 mandatory policy from Government of Republic of Indonesia. Following on the increase of net revenue, the net profit attributable to the owners of the company also increase by 891.8% on March 2020 to Rp 371 billion compared to the same period last year.
