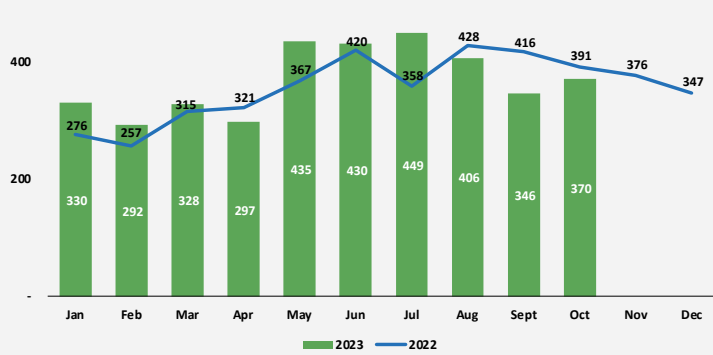

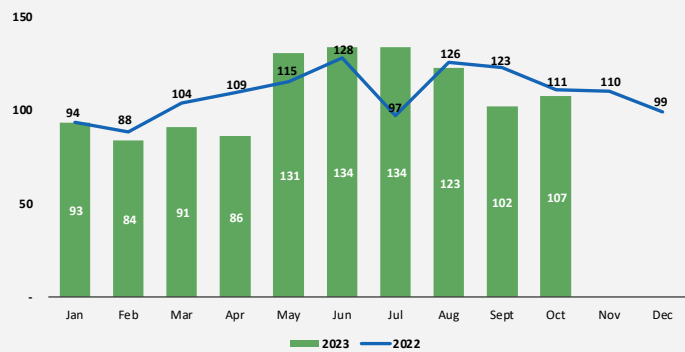
PT Astra Agro Lestari Tbk ("the Company") as of October 2023 has produced 3.7 million tons of Fresh Fruit Bunches (FFB), or an increase of 3.7% compared to YTD October 2022. This increase was in line with the 5.6% increase in nucleus FFB production as of October 2023 compared to the same period in 2022.

The Company also produced 1.1 thousand tons of Crude Palm Oil (CPO) as of October 2023, which decrease by 0.9% compared to YTD October 2022. This was in line with the decrease in Kernel production by 2.0% to 233 thousand tons as of October 2023 compared to as of October 2022 of 238 thousand tons.

The Company recorded a 5.1% decrease in net revenue from Rp 16.5 trillion as of September 2022 to Rp 15.7 trillion as of September 2023. This was due to a 15.8% decrease in the Company's average CPO price and a 44.8% decrease in the average Kernel price as of September 2023 compared to September 2022. The decrease resulted in a 34.2% decrease in profit attributable to owners of the Company from Rp 1.2 trillion as of September 2022 to Rp 801 billion as of September 2023.
